News from the Programs Team: We have two interesting programs coming up!

Thursday March 7 at 6.30 p.m.: Our speaker will be **Veronica Degraffenreid**, former Secretary of State of the Commonwealth of PA, who is now working at the Brennan Center for Justice. Her career experience includes working as a special advisor for election modernization with the Pennsylvania Department of State. Ms. Degraffenreid also served on the North Carolina State Board of Elections for over a decade. The Brennan Center for Justice at New York University School of Law is a liberal or progressive nonprofit law and public policy institute.

Thursday April 4 at 6:30 p.m.: Our speaker will be **Dorene Wilbur**, who is the Diversity, Equity, Inclusion, and Belonging specialist at the PA Office of the Attorney General. We will be hearing about what the PA Attorney General's office has implemented on DEIB and their expectations for various non-profit, non-partisan groups like LWV in our DEI implementations. Ms. Wilbur has a master's in education and has worked in the DEIB area for several years. She is a former teacher at Carlisle Area School District and has been involved with the Truth and Reconciliation Commission where she has been a staunch advocate for children. She was the recipient of the Jim Washington Station of Hope Award on Feb. 25th, 2023. Recently she was the keynote speaker for the Carlisle Area 35th Annual Rev. Martin Luther King, Jr. Commemoration where she represented the Office of the PA Attorney General.

In February we celebrated **Black History Month.** February includes the birthday of Abraham Lincoln on February 12 and Frederick Douglass on February 14. Douglass was a slave who escaped slavery in Maryland and became the face of the abolitionist movement. February 1 is National Freedom Day, when President Lincoln signed the 13th Amendment which abolished slavery. February 4 is Rosa Parks Day.





Other important days in February were the Lunar New Year which occurred on February 10. It signifies the first new moon of the year. It is also the Chinese New Year (Year of the Dragon).

February 15 was the Buddhist Nirvana Day and February 20 was the World Day of Social Justice.

To honor Black History Month, there are several books related to black history that are currently popular and highly recommended. Most have been banned by anti-DEI groups. <u>Caste</u> and <u>The Warmth of Other Suns</u> by Isabel Wilkerson: <u>Caste</u> explains the origin of racism and why racism still exists in various countries. <u>The Warmth of Other Suns</u> tells the story of the great migration of black people from the South to the Northern and Western parts of the United States after the Reconstruction period was ended. The Pulitzer Prize-winning book <u>The 1619 Project</u> written by Nikole Hannah-Jones is also highly recommended. T<u>he Immortal Life of Henrietta Lacks</u> by Rebecca Skloot deals with ethical issues of race and class in medical research. It describes the immortal cell line, known as HeLa, that came from Lacks's cervical cancer cells in 1951 with no consent from her or her family.

Movie recommendations are <u>Emancipation</u>, a 2022 movie starring Will Smith. It tells the story of a slave who escapes from Louisiana to make a dangerous journey north. It is based on a true freedom story of Gordon/Whipped Peter who escaped and became a Union soldier in the Civil War.

<u>Thirteen Lives</u> is a movie about the rescue of a group of young boys and their soccer coach who are trapped in an underground cave in Thailand. The boys and the coach were trapped for 18 days in the underground cave and the rescue took 6 hours to extract all of them. There was a complication because 3 of the boys were stateless and came from Laos, China, and Myanmar.

Update on the Patricia L. Murray Fund grant Guide to Voting

We have now completed the translation of our Guide to Voting in six languages--Arabic, Nepali, Somali, Spanish, Urdu, and Vietnamese. They will be distributed to several YMCAs in our area, and potentially several libraries. These distribution sites will enable us to reach a larger demographic base such as teenagers who may be eligible to register to vote, young parents, and persons with English as a second language. We are also working with libraries to set up displays and materials prior to the primary election in April.

Thank you to member Joe M who keeps us abreast of what is happening in our state legislature. Joe provided an overview on the nature, and implications, of the lawsuit recently filed in federal district court for the middle district of Pennsylvania, titled "Rep. Dawn Keefer et al vs. President Joseph Biden and Governor Josh Shapiro et al." The purpose of this suit is to restrain the executives' ability to ease the voting registration process. The Plaintiffs bringing the lawsuit are Pennsylvania legislators, mostly allied with the conservative Freedom Caucus.
